ORDER NO. 7
SEVERING CASE AND REMANDING TO THE EXECUTIVE DIRECTOR

On June 15, 2004, the City of Royse City (Royse City) moved to remand its two pending applications to the Executive Director (ED) of the Texas Commission on Environmental Quality for further processing. In the motion, Royse City notes that it has settled all contested issues related to its applications, no parties continue to oppose the applications, and all parties agree to the applications being remanded. After considering Royse City's motion, the undersigned Administrative Law Judge (ALJ) concludes that the motion is well-founded. Therefore, it is **ORDERED** that Royse City's application to amend Water Certificate of Convenience and Necessity (CCN) No. 12827 (Application No. 34270-C), and Royse City's application to obtain a Sewer CCN (Application No. 34277-C), which are docketed as TCEQ Docket No. 2003-0737-UCR, are hereby severed from SOAH Docket No. 582-04-0253 and are remanded to the ED pursuant to 30 TEX. ADMIN. CODE § 80.101. Because a CCN application by Verandah Communities, LP, remains pending in SOAH Docket No. 582-04-0253, that docket shall remain in effect.
