



Attached please find the request that Parker Creek Estates, LP sent to the City of Royse City via its consulting engineers, Pate Engineers. Mr. Robert Wright, PE's transmittal letter to me attesting to identical letters being sent to the City of Fate is also attached. I had asked Mr. Wright to send me the letters to both Royse City and Fate in response to a request from Prabin Basnet and this is what Mr. Wright was able to send me.

As to the area of overlap with Royse City, the landowner in question is the applicant in this case who is working to create a water district to assume this application. The City's service is neither wanted nor needed. While my clients and I are meeting with Royse City to resolve this matter amicably, if necessary we will demand a full evidentiary hearing before SOAH to rid the property of the blight of Royse City's CCN application. Royse City does not have any available sewer capacity since its plant is over capacity and will not be expanded until long after the need for service to this property is well under way. Royse City is too distant to serve the property economically and wants a CCN for land use purposes.

As to your letter about giving notice to Verandah Communities, LP, please be advised that Verandah Communities, LP is an affiliate under common ownership and control, which I also represent. They have actual notice as a mater of law. No additional notice or proof of notice is required.


