
This firm represents the City of Royse City, Texas ("Royse City"). Royse City hereby requests an amendment to its pending Application No. 34270-C for amendment to Water Certificate of Convenience and Necessity ("CCN") No. 12827 and its pending Application No. 34277-C to obtain a Sewer CCN. Such amendments are necessary to conform the proposed service areas sought by Royse City to those territories designated and described in the Settlement Agreement entered into by Royse City and the City of Fate ("Fate"), which has previously been filed in the above-referenced consolidated dockets and SOAH Docket No. 582-04-2730, TCEQ Docket No. 2003-1491-UCR, *Application of the City of Fate to Amend Water CCN No. 12889 and to Amend Sewer CCN No. 20856 in Rockwall County.* Royse City anticipates that it will further amend its two pending applications in the next few days after additional settlement agreements have been finalized between Royse City and Parker Creek Estates, L.P., Verandah Communities, LP, and the Verandah Freshwater Supply District.

Attached are two maps, previously submitted as exhibits to the Royse City/Fate Settlement Agreement, which identify the proposed amendments to Royse City's pending sewer and water CCN applications. As identified on the maps, the Royse City/Fate Settlement Agreement provides for exclusions from the territories originally sought by Royse City's applications and results in a reduction in the areas sought for certification. No new areas are being sought pursuant to these requested amendments. Royse City will also be submitting electronic data to the appropriate Commission staff identifying the specific proposed CCN boundaries as a result of this request for amendments.
