Dear Mr. Holcomb:

This firm represents the City of Royse City, Texas ("Royse City"). Royse City hereby requests an amendment to its pending Application No. 34270-C for amendment to Water Certificate of Convenience and Necessity ("CCN") No. 12827 ("Royse City Water CCN Application") and its pending Application No. 34277-C to obtain a Sewer CCN ("Royse City Sewer CCN Application"). Such amendments are necessary to conform the proposed service areas sought by Royse City to those territories designated and described in two Settlement Agreements entered into by Royse City and other parties in the above-referenced consolidated docket. The Royse City/Verandah Settlement Agreement entered into by Royse City, Verandah Communities, LP ("Verandah LP"), and the Verandah Fresh Water Supply District ("Verandah FWSD") requires Royse City to amend the Royse City Sewer CCN Application to remove the area identified in the Verandah LP Sewer CCN Application from the territory sought by the Royse City Sewer CCN Application. The Royse City/Parker Creek Settlement Agreement entered into by Royse City and Parker Creek Estates, L.P. ("Parker Creek L.P.") requires Royse City to amend the Royse City Sewer CCN Application and the Royse City Water CCN Application to remove the areas identified in the Parker Creek Sewer CCN Application and the Parker Creek Water CCN Application from the territories sought by the Royse City applications.

Attached are four maps, which identify the proposed amendments to the pending Royse City Sewer CCN Application and the pending Royse City Water CCN application. No new areas are being sought pursuant to these requested amendments. Royse City will also be submitting electronic data to the appropriate Commission staff identifying the specific proposed CCN boundaries as a result of this request for amendments.
