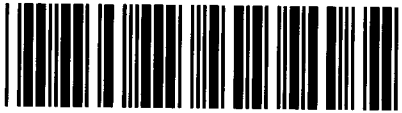

ORDER NO. 5  
CONTINUING HEARING ON THE MERITS AND  
SETTING STATUS REPORT DEADLINE

On February 1, 2006, the Parties filed a joint status report stating that a complete settlement of contested matters is anticipated in approximately one month. As the end of a 30-day drafting period would fall after the scheduled date of the hearing on the merits on February 20-22, 2006, the Administrative Law Judge hereby *continues indefinitely* the hearing on the merits and associated prehearing conference.

If the Parties have not filed motions for withdrawal and remand as anticipated, the Parties shall update their status report *on or before March 31, 2006*, or file appropriate motions for further proceedings, including resetting of the hearing on the merits if required.
