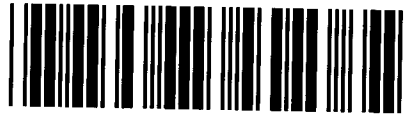

**ORDER NO. 1
GRANTING MOTION TO REMAND AND
DISMISSING FROM DOCKET**

At the hearing on the above-captioned matter held in Austin, Texas, on April 24, 2007, the Administrative Law Judge (Judge) found that notice had been properly given and designated the following as parties to the proceeding: Applicant New Water Supply Corporation (represented by Ray Moore, consulting engineer); the Executive Director (ED) of the Texas Commission on Environmental Quality (represented by Christiaan Siano, Staff Attorney); and the Commission's Public Interest Counsel. Although protests to the application had been filed, no protesting party appeared. After being an opportunity to negotiate, the parties reached an agreement that settled all issues in controversy. A motion was made to remand the matter to the ED. The Judge considers the motion has merit and should be granted.

THEREFORE, IT IS ORDERED that, pursuant to 30 TEX. ADMIN. CODE § 80.101, the above-captioned matter is remanded to the ED of the Texas Commission on Environmental Quality and the case is dismissed from the docket of the State Office of Administrative Hearings.
