# ORDER NO. 4 GRANTING MOTION TO REMAND AND DISMISSING CASE FROM SOAH DOCKET

On January 30, 2007, the Village of Wimberley filed a motion to withdraw its application for certificate of convenience and necessity (CCN) and to remand the above-captioned matter to the Executive Director of the Texas Commission on Environmental Quality (ED) for appropriate action in light of the application withdrawal.

The undersigned Administrative Law Judge, having considered the motion, finds that it has merit and should, therefore, be granted.

Accordingly, **IT IS ORDERED** that the motion to withdraw CCN application and to remand is hereby **GRANTED**.

**IT IS FURTHER ORDRED** that this case is dismissed from the docket of the State Office of Administrative Hearings and shall be remanded to the ED for further action.
