**ORDER NO. 3
GRANTING MOTION TO EXTEND DEADLINES**

On January 5, 2007, the Village of Wimberly (Wimberly) filed a motion to extend, from January 10, 2007, to January 31, 2007, its deadline to file a response to Aqua Texas' motion to dismiss Wimberly's application. It also asks that the deadline to reply to its response be extended to February 16, 2007. Wimberly asks for a delay so that its city council can consider this and related matters at its January 18, 2007, meeting, at which the council may take that action and would impact Wimberly's response.

Aqua Texas, the Executive Director (ED), the Public Interest Counsel (PIC), and the City of Woodcreek, which the Administrative Law Judge's (ALJ's) assistant contacted for a response, do not oppose the motion. The ALJ's assistant and Wimberly have tried but obtained no response from Roger J. Engemoen on behalf of the Estelle Ervine Engemoen Trust. Because Wimberly's deadline is today and the motion appears reasonable, the ALJ will not wait longer for a response. The motion is granted.
