


**ORDER NO. 6**  
**REMANDING CASE TO EXECUTIVE DIRECTOR**

On May 14, 2003, the City of San Juan filed a Motion to Remand the above-referenced matter. In March, Military Highway WSC and North Alamo WSC filed letters indicating that all matters of controversy in this case were settled. Accordingly, a contested case hearing is no longer necessary. This matter is properly remanded to the Executive Director, pursuant to 30 TEX. ADMIN. CODE §§ 70.10( c) and 80.101.

The motion is **GRANTED**, and it is **ORDERED** that this case is **REMANDED** to the Executive Director for further administrative processing and is **DISMISSED** without prejudice from the docket of the State Office of Administrative Hearings.
