ORDER

An application by the City of San Juan ("San Juan") to obtain a Certificate of Convenience and Necessity ("CCN") to provide water service and to decertify a portion of North Alamo Water Supply Corporation's ("NAWSC") CCN No. 10553 in Hidalgo County, Texas, was presented to the Executive Director of the Texas Commission on Environmental Quality ("Commission") for approval pursuant to Section 5.122 of the Texas Water Code and Commission rules.

San Juan seeks a CCN for the provision of water service in Hidalgo County, Texas, as a retail public utility as defined in Section 13.002(19) of the Texas Water Code.

On March 18, 2002, San Juan filed an application with the Commission pursuant to Section 13.241, et. seq., of the Texas Water Code to obtain a water CCN to provide water service in Hidalgo County, Texas, and to decertify a portion of NAWSC's CCN in Hidalgo County, Texas. The application was accepted for filing and was assigned Application No. 33028-C. San Juan provided notice to affected persons and neighboring utilities on June 11, 2002. Notice of the application was

published on June 8, 2002, and June 12, 2002, in <u>The Monitor</u>, a newspaper generally circulated in Hidalgo County, Texas. The notice to obtain a CCN by San Juan and to decertify a portion of NAWSC's CCN complied with the notice requirements of Title 30, Section 291.106 of the Texas Administrative Code and was sufficient to place affected persons on notice regarding the application for service and the request for decertification. The Commission received a request for a public hearing on the application from NAWSC and Military Highway Water Supply Corporation ("MHWSC").

On February 10, 2003, Tommy L. Broyles, an Administrative Law Judge with the State Office of Administrative Hearings ("SOAH"), denied a motion for continuance and scheduled a preliminary hearing to take place via teleconference on February 11, 2003. Judge Broyles convened the preliminary hearing on February 11, 2003, but did not take jurisdictional documents or name parties. Judge Broyles scheduled a second preliminary hearing on March 20, 2003, in order to allow the parties additional time to negotiate a settlement agreement. NAWSC and MHWSC filed letters withdrawing their respective protests of the application, confirming that the dispute had been resolved, and agreeing to the portions of CCN No. 10553 that were being decertified from NAWSC as part of the settlement. Judge Broyles canceled the second preliminary hearing by Order dated March 17, 2003.

On May 14, 2003, San Juan filed a Motion to Remand on the basis of the settlement, stating all issues in dispute had been resolved. Judge Broyles granted the motion on May 15, 2003, dismissed the case from the SOAH docket because no contested issues remained, and remanded the application to the Executive Director for further handling pursuant to Title 30, Section 80.101 of the Texas Administrative Code.

San Juan is capable of rendering adequate and continuous service to every customer in the area proposed to be included in Application No. 33903-C and the certification of San Juan is necessary for the service, accommodation, convenience, or safety of the public.

NOW, THEREFORE, BE IT ORDERED BY THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY that:

The application by the City of San Juan for a water Certificate of Convenience and Necessity (CCN) No. 12874 and to decertify a portion of North Alamo Water Supply Corporation's CCN No. 10553 in Hidalgo County, Texas, as reflected in the attached copy of official water service area map of Hidalgo County, Texas, is hereby approved.

The Chief Clerk of the Texas Commission on Environmental Quality shall forward a copy of this Order to the parties, and the Commission will issue a Certificate of Convenience and Necessity to the City of San Juan.

If any provision, sentence, clause, or phrase of this Order is for any reason held to be invalid, the invalidity of any portion shall not affect the validity of the remaining portions of the Order.
