<u>Manville Water Supply Corporation</u>, has filed an application to decertify a portion of CCN No. <u>11144</u> with the Texas Commission on Environmental Quality to provide <u>water</u> utility service in <u>Travis</u> County.

The proposed service area to be decertified is located approximately  $\underline{2}$  miles <u>north</u> of downtown <u>Manor</u>, Texas, and is generally bounded on the north by <u>undeveloped land and Gregg Lane</u>; on the east by <u>F.M. Road 973</u>; on the south by <u>U.S. Highway 290 East</u>; on the west by <u>Wilbarger Creek</u>. See enclosed map of the proposed service area.

The total being requested includes approximately 329.318 acres and 0 current customers.

A request for a public hearing must be in writing. You must state (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, application number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application or CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.

If a public hearing is requested, the Executive Director will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, the SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.
