
ORDER NO. 6

On January 11, 2002, Hornsby Bend Utility Company filed a status report in this case, as required by Order No. 5. Hornsby Bend requested that this case be abated for another ninety days while settlement negotiations continue. That request is **GRANTED**.

Hornsby Bend asked the Administrative Law Judge to consolidate this case with the City of Austin's pending applications if the State Office of Administrative Hearings does not receive a comprehensive settlement agreement within ninety days. The ALJ declines to do so. Instead, no later than April 19, 2002, Hornsby Bend shall file a status report and, if appropriate, a motion to consolidate the cases. The motion shall set out the docket numbers for the City of Austin cases and briefly discuss the status of those cases.
