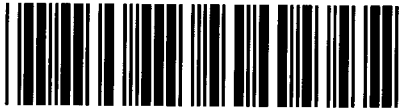

ADMINISTRATIVE HEARINGS**ORDER CONFIRMING DISMISSAL**

On July 30, 2002, the undersigned ALJ issued a Conditional Order of Dismissal in the captioned action, pursuant to 1 TEX. ADMIN. CODE ("TAC") § 155.57(b). The issuance of the order was based upon the failure of the applicant, Water Necessities, Inc., to appear at a preliminary hearing scheduled in Austin, Texas, on July 30, 2002. This action, initiated on behalf of the applicant, thus became subject to dismissal for applicant's failure to prosecute it properly.

The Conditional Order of Dismissal informed applicant that the dismissal of the captioned matter from the docket of the State Office of Administrative Hearings would become final upon the expiration of 20 days from the date of the order, unless a properly supported motion to set aside such dismissal and reopen the record was filed with the ALJ within that 20-day period. The 20-period has elapsed, and the applicant has submitted to the ALJ no motion relating to this matter.

Accordingly, the dismissal of the captioned action is confirmed, and the matter is hereby remanded to the Executive Director of the Texas Natural Resource Conservation Commission for appropriate administrative action.
