#### Dear Mr. Garza:

As you may recall, we met at the meeting of Bexar County Emergency Services District No. 6 a few weeks ago. At that time, you explained to me and the audience, generally, the City of San Antonio's annexation plans with respect to south Bexar County, which you referred to as the "Southside Initiative Expansion Area." I understood you to say that annexation of that area was proposed, but had not been finalized by a vote of the City Council, which is required for formal annexation.

I have now turned my attentions northward, to the area of Bexar County generally bounded by Hwy 281 on the east, Camp Bullis on the west, Borfeld Road on the south, and the Cibolo Creek to the north. This area is just north of the Timberwood Park and Oliver Ranch subdivisions.

Please provide me with any publicly-available information concerning formal annexation efforts or planning by the City with respect to that area. In particular, I am interested in learning whether there exists a finalized plan for annexation, or whether there has been formal action by the City Council to commence annexation proceedings in that area.

Thank you, again, for your honest and thorough presentation and assessment concerning south Bexar County. I look forward to receiving equally comprehensive information for this area to the north.
