ORDER NO. 14 CONTINUING HEARING ON THE MERITS, SETTING MOTION HEARING, AND REQUIRING PROPOSED SCHEDULE

Further the parties agreed that the hearing on this, or other summary disposition motions that may be filed, will be based on pleadings and accompanying materials per 1 Tex. Admin. Code § 155.57 and 30 Tex. Admin. Code § 80.137.
