# ORDER NO. 16 ABATING FURTHER PROCEEDINGS FOR TIME CERTAIN AND REQUIRING A REPORT

On October 18, 2005, after hearing argument of the Parties, further proceedings in this case were abated for a period of three months, through January 15, 2006. On or before that date, the Parties should–jointly or individually–file a report on the status of the proceeding pending in Comal County in regard to Bexar Metropolitan Water District's service territory boundaries, or any appeals from that case, and advise the Administrative Law Judge (ALJ) on whether the pending summary disposition motion by Bitterblue, Inc. has become ripe for a decision.

During this period, the Parties may file motions in regard to other matters that may require disposition during that time.


