In accordance with your Order requiring a report on the status of the lawsuit pending in Comal County district court, I furnish the enclosed correspondence from David Blanke, lead counsel for GBRA. As reflected in Mr. Blanke's letter, the parties in that lawsuit had initially agreed to have cross-motions for partial summary judgment heard on March 30, 2006. However, the Court is unavailable on that date, so the dates of April 11 and 12 are presently being considered.

Given the significant delay associated with having Judge Steele rule on the cross-motions, and the likelihood that he takes such motions under advisement, BexarMet respectfully requests that you lift the abatement entered in this cause, set a date for hearing on the merits, and enter a new scheduling order which reasonably allows the parties to prepare for such hearing.


