## **ORDER NO. 18 REQUESTING ALTERNATE HEARING DAYS**

On May 4, 2006, Applicant proposed a schedule agreed to by the Executive Director of Texas Commission on Environmental Quality and Bitterblue, Inc. Sneckner Partners, Ltd., has not commented. The proposed prehearing schedule appears reasonable and the Administrative Law Judge (ALJ) proposes to adopt it in large part.

However, the proposed hearing dates and immediate prehearing calendar do not appear workable. As scheduled, the evidentiary objections and motions to be ruled on immediately before the hearing-usually a major task on a case of this complexity-would have to be handled by a judge other than the assigned judge.<sup>1</sup> This would result in duplicated and inefficient work.

The ALJ requests that the parties consider the following alternative hearing dates, either October 23-27 or October 30-November 3, 2006. On or before May 15, 2006, the parties should indicate whether they would be available for either of the proposed alternate settings or propose a third alternative.<sup>2</sup>

In the event some days on the week of October 16, 2006, are considered, the parties are advised that on October 20, 2006, a Friday, the State Office of Administrative Hearings hearing
