Dear Judge Church:

On late Friday afternoon, I received a copy of BexarMet's letter to you regarding San Antonio Water System's Motion to Intervene in this matter. In the letter, BexarMet implies that the deadline to respond to SAWS' motion is August 29, 2005.

BexarMet confirms that it received a copy of SAWS' motion on August 18, 2005. My reading of SOAH's procedural rules, therefore, puts BexarMet's deadline to respond as August 25, 2005 (seven calendar days after the motion is served – 1 TAC § 155.29(e)) and not August 29, 2005.

SAWS respectfully requests that you clarify that any responses to SAWS's motion are due on August 25, 2005. If you determine that you need oral argument regarding the motion, we request that the hearing be held live, rather than by telephone conference, given the nature of SAWS' motion and its potential impact on the schedule in this matter. For your information, we will be unavailable for a hearing on Friday, August 26 and August 31, but we will be available on all other days next week.
