This correspondence is sent for the purpose of updating and amending the Application to Amend Water CCN 10675 filed by Bexar Metropolitan Water District ("BexarMet"), on or about March 1, 2002. The filing was assigned Application No. 33862-C, and has subsequently been assigned TCEQ Docket No. 2003-0664-UCR and SOAH Docket No. 582-03-3725. As you know, the application has been referred to SOAH, and is presently pending before the Honorable Cassandra J. Church, Administrative Law Judge.

B. LOCATION INFORMATION

- 1. Some people living within the proposed area are currently receiving water utility service from BexarMet. More particularly, BexarMet is currently providing service to 14 connections located within the Canyon Ranch Estates subdivision. Service is provided to those through an existing 12" main which delivers water from a well site and 458,000 gallon ground storage tank located within BexarMet's existing Timberwood PWS.
- 2. BexarMet has received numerous requests for service in the area. These requests have come both in writing and verbally. The requests have been submitted among others: Pape-Dawson Engineers, Brown Engineering Co., Norfolk Properties, Ltd., Denton Communities, Gordon Hartman Homes / W.F. Castella and Associates, and Bitter Blue, Inc. BexarMet also received written notice that two other landowners David Mann and Randy Dym desire BexarMet' water service in the area. Utility Service Agreements have been entered with developers of the Venado Creek Subdivision (71 lots) and with Centex for 600 EDUs (Friesenhahn I). The district is presently negotiating with the developers of the two Monte Cristo Subdivisions for water service to 260 lots.



1	Q.	Please state your name and business address for the record.
2	А.	Michael J. Albach, I office at 2047 W. Malone, San Antonio, Texas 78225
3	Q.	By whom are you employed and in what capacity?
4	А.	I am employed by Bexar Metropolitan Water District ("BexarMet") as its Director
5		of Operations. I was formerly employed as BexarMet's Deputy General Manager for
6		Water Resources. I have been employed by BexarMet since 1996.
7	Q.	Have you previously rendered testimony in this proceeding?
8	А.	Yes. I have also recently filed a supplement to my testimony. This second supplement
9		is filed by agreement of the parties, and is submitted for the purpose of clarifying,
10		updating and making more accurate my previous testimony concerning:
11		a BexarMet's present service to parts of the proposed area;.
12		b. Additional requests for BexarMet's Service in the proposed area; and
13	4	c. BexarMet's resources available for public service;
14	Q.	Have you reviewed the Application for CCN amendment made the basis of this
15		proceeding since you rendered your initial testimony in this cause?
16	А.	Yes, I have. In my most recent review of the application, I noticed some information
17		which, although true in 2002, is no longer accurate. On June 28, 2006, an
18		amendment/update of the CCN Application was submitted to the TCEQ. I have
19		attached that amendment/update as Exhibit 30.
20	BexarMet's	Service to the Proposed Area
21	Q.	Is BexarMet presently providing any service to the proposed CCN area?
22	А.	In addition to our existing service to adjacent and contiguous areas directly to the

Albach Page 2 of 4 south and west of the proposed area (in our existing Timberwood PWS), BexarMet 1 is presently providing service to 14 meters located at residences constructed in the 2 3 Canyon Ranch Estates subdivision. Some of these meters provide service to model 4 homes, as this subdivision is being newly constructed. 5 Q: How is BexarMet providing this water service? 6 We are using an existing 12" main to deliver water from an existing well and 458,000 A: 7 gallon ground storage tank located just south of Borgfeld Road (north of Slumber 8 Pass and west of Harmony Hills) to the Canyon Ranch Estates subdivision. 9 Will the existing 12" main be used to provide service to other developments in the Q: 10 proposed service area? It is my understanding that the portion of the existing main which runs (east-west) 11 A: parallel to Borgfeld Road will be extended westward to Sherwodd Forest Road, 12 thereby allowing service to the Monte Cristo and Venado Creek developments, which 13 14 are located just north of Borgfeld Road. Additional Requests for BexarMet's Service 15 Has BexarMet has received additional requests for service in the proposed area since 16 Q. 17 the time you rendered your initial pre-filed testimony? Yes. On February 2, 2006, BexarMet entered into a Utility Services Agreement 18 Α. ("USA") to provide water to 600 EDU's in a subdivision to be constructed by 19 Centex Homes, Inc. on the Friesenhahn I tract. This USA has previously been 20 tendered to the pre-filed record as Exhibit 26. In addition, BexarMet has entered into 21 22 a USA with the developer of the proposed Venado Creek subdivision. This

1	subdivision is projected to have 71 lots, and is located directly north of and
2	contiguous to our existing Timberwood PWS (on the north side of Borgfeld Road).
3	BexarMet representatives have also recently met with representatives of the
4	proposed Monte Cristo subdivisions for the purpose of providing water to two
5	developments with 88 lots and 182 lots, respectively. The proposed Monte Cristo
6	developments are both situated on the north side of Borgfeld Road, and are directly
7	north of and contiguous to our existing Timberwood PWS.
8	BexarMet's resources available for public service
9	Q. Please identify any new, contemplated or potential water sources, which BexarMet
10	may be utilize to serve the proposed area.
• 1 1	A. As I have previously testified, BexarMet has entered into a contract with Water
12	Exploration Company ("WECo") to produce water from sixteen Trinity Aquifer
13	wells. On June 21, 2006, the BexarMet Board of Directors approved the purchase
14	from Canyon Valley, Ltd. of an existing well and 34 surface acres. The well has been
15	drilled to Public Water Supply standards, and is fully operational. BexarMet will
16	utilize this well, and additional wells to be drilled on the 34 acre tract to supply the
17	proposed service area. In addition, construction of Water Well No. 5 at the Wild
18	Turkey Station has been completed. The District is in the process of setting the pump
19	in this well. Once online, Well #5 will supplement the existing wells at the Wild
20	Turkey station, and will be utilized to serve both the existing Timberwood PWS and
21	the proposed area. Finally, BexarMet is constructing new Edwards Aquifer wells at
22	Fleetwood (in Hollywood Park) and at Bitters (in Hill Country Village). These
