Dear Judge Church:

I have received Bitterblue, Inc.'s Motion to Revise and Clarify Order No. 22, as well as BSR's "Motion" in support thereof.

Please be advised that I have been in communications with Bitterblue's counsel, Ron Freeman, and advised him that BexarMet may agree to the relief requested in Paragraph V(2) of the Motion to Revise However, any such agreement (if it is to be had at all) must be authorized by the District's Board of Directors. The Board's next regular meeting is scheduled for July 24, 2006, and the Agenda for that meeting contains an item related to possible resolution of the dispute with Bitterblue, Inc.

In the event that the Board declines or is unable to resolve the dispute with Bitterblue, I intend to file a Response to the Motion to Revise on BexarMet's behalf. However, doing so at this time would be premature and a waste of resources. As such, I respectfully request that you forbear from ruling upon the Motion to Revise until after July 27, 2006 so that the entities may either resolve their differences, or provide full briefing on the propriety of Order No. 22.
