ORDER NO. 10 SETTING HEARING ON MOTION TO INTERVENE AND RESPONSE DEADLINES

On August 17, 2005, San Antonio Water System (SAWS) moved to intervene in this case, or in the alternative, to have the case abated or remanded to the Executive Director (ED) of Texas Commission on Environmental Quality (TCEQ). On August 25, 2005, Bexar Metropolitan Water District opposed granting any of the relief that SAWS requested.

A hearing on SAWS' motions will be conducted at 1:30 p.m. on September 1, 2005, at the William P. Clements Jr. Office Building, 300 West 15th, Fourth Floor, Austin Texas.

Responses by the ED or BSR Water Company, if any, are due on or before 5 p.m. on August 30, 2005.

Any party wishing to appear by telephone should file a motion in accordance with SOAH's rule on telephone appearances.

In the event a telephone appearance is granted, any documents not attached to pleading already on file at SOAH that a party intends to introduce at the hearing must be exchanged in advance of the scheduled time of the hearing.
