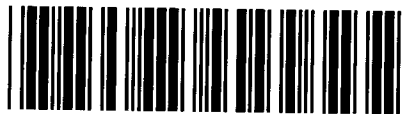

Dear Judge Church:

By correspondence dated August 2, 2006, Bitterblue, Inc. respectfully requested a ruling on its "Motion to Revise and Clarify Order No. 22 Ruling on Motion for Dismissal by Summary Disposition" prior to certain upcoming discovery and other deadlines in this matter. As noted by Bitterblue, a ruling on that Motion may very well render those deadlines moot.

Like Bitterblue, BSR has filed a motion seeking to have the entire CCN Application filed by Bexar Met dismissed based on Bexar Met's inability to service the area requested in the Application. Currently, BSR's pre-filed testimony must be filed by August 11, 2006. BSR sought an extension on that deadline from Bexar Met via a Rule 11 Agreement in light of the continuing discovery and outstanding motions in this matter, but that request was denied. However, assuming Bexar Met's Application is dismissed for lack of statutory authority, as BSR believes it should be, this August 11th deadline will become moot. In the interest of economy, BSR would also respectfully request a ruling on Bexar Met's inability to service the area requested prior to August 11th.


