At the September 3, 2002, preliminary hearing, TNRCC Docket No. 2002-0756-UCR (Application of Hornsby Bend Utility Company, Inc. to amend Water CCN 11978 in Travis County) was consolidated with the other applications pending in this docket, Capital Pacific Holding's request to withdraw as a party was granted, and guidance was provided regarding requested adjustments to the procedural schedule. On September 10, 2002, the parties submitted a joint request to amend the procedural schedule in order to accommodate the taking of depositions following the submission of prefiled testimony. The joint motion is granted, and the requested revisions are incorporated into the procedural schedule for this hearing.
