RULE 11 AGREEMENT TO EXTEND TIME TO TAKE DEPOSITIONS AND TO FILE PREFILED TESTIMONY

A. Introduction

The City of Austin ("City") and Hornsby Bend Utility Company ("Hornsby") file this agreement, made pursuant to Texas Rules of Civil Procedure 11 and 191.1, and 1 TAC § 155.31 to extend time to notice and take depositions, and to file prefiled testimony. Geoffrey Kirshbaum, representing the Executive Director, does not oppose the time extensions found in this agreement.

1. Discovery in this hearing is governed by Order No. 11, a scheduling order signed by Judge Sullivan on June 13, 2003. Under Order No. 11, the parties are to conclude depositions

by July 3, 2003, and Applicants are to file their prefiled testimony by August 1, 2003. The case is set for hearing beginning on October 6, 2003.

B. Agreement

- 1. The City and Hornsby agree to extend the time for taking depositions to July 11, 2003.
- 2. The City and Hornsby agreed to extend the time when each must file its prefiled testimony to August 8, 2003.
- 3. The City and Hornsby agree that no additional witnesses will be added to either parties' witness lists.
- 4. The signatures below evidence the City's and Hornsby's intent that this shall serve as a Rule 11 agreement, enforceable upon filing with the State Office of Administrative Hearings.
