# STATUS REPORT AND JOINT MOTION TO CONTINUE ABATEMENT

## TO THE ADMINISTRATIVE LAW JUDGE:

## I. Introduction

The City of Austin ("City") and Hornsby Bend Utility Company, Inc. ("Hornsby"), also referred to as "the Parties," file this Status Report and Joint Motion to Continue Abatement, and in support of this motion submit the following:

#### II. Basis for Motion

On September 10, 2003, the Parties filed an Agreed and Unopposed Motion to Abate. This motion requested that this proceeding be abated until October 13, 2003 in order to accommodate ongoing settlement negotiations. The Parties also stated that they anticipated filing a motion to dismiss their protests of each other's applications on October 13. In Order No. 16, issued on September 17, 2003, the ALJ granted the motion to abate and instructed the Parties to file either an agreed motion to dismiss or an updated status report by October 13, 2003.

The Parties are now pleased to report that they will be executing a comprehensive settlement agreement within the next few days. The additional delay is in large part due to the significant number of individuals on both sides that are involved in the review, approval, and execution of the draft documents. Both sides are moving as quickly as possible, however, and are confident that this settlement can be completed this week.

Consequently, the Parties file this status report and motion to continue the abatement period until October 17, 2003. Counsel for the Executive Director could not be reached at the time this motion was filed.

### III. Prayer

For the reasons set out above, Hornsby and the City respectfully request that the ALJ abate these proceedings until October 17, 2003.
