**ORDER NO. 11**  
**ADOPTING SUPPLEMENTAL PROCEDURAL SCHEDULE**

**I. Notice**

On October 5, 2015, Trinity SO PTN, LP (Trinity SO or Applicant) filed affidavits of notice, along with a copy of the notices sent, and an affidavit verifying publication of notice. According to the affidavits, notice to customers was accomplished by door to door delivery on September 15, 2015, notice was mailed to neighboring systems, landowners and cities on September 18, 2015, and published in the *Woodlands Villager* on September 10, 2015 and September 17, 2015. Public Utility Commission of Texas (Commission) Staff found Trinity SO's notice sufficient; therefore no additional notice is necessary.

**II. Supplemental Procedural Schedule**

On October 16, 2015, Commission Staff filed a proposed supplemental procedural schedule. On October 19, 2015, Commission Staff filed an amended proposed procedural schedule requesting additional time for review of the application. The amended proposed procedural schedule is adopted:



Deadline for intervention, deadline for intervenors to file comments or request a hearing on the merits (30 days after mailing or publication of notice whichever occurs later)	October 19, 2015 <sup>1</sup>

<sup>1</sup> The 30<sup>th</sup> day is Sunday, October 18, 2015. Thus, pursuant to 16 TAC § 22.4 the period shall conclude on the end of the next day on which the Commission is open for business.

Deadline for Commission Staff to provide revised maps and certificates to the parties for review and consent	December 16, 2015
Deadline for Parties to file signed consent forms with the Commission showing consent to revised maps and certificates	January 6, 2016
Deadline for Commission Staff's recommendation on final disposition	January 13, 2016
Deadline for Staff and Applicant to file a joint proposed notice of approval, including necessary maps, certificates, or other necessary documents	January 20, 2016
