APPLICATION OF TRINITY RTC GP, § PUBLIC UTILITY COMMISSION LLC TO OBTAIN WATER AND § FILING CLERK SSION OF TEXAS CONVENIENCE AND NECESSITY IN § HARRIS COUNTY §

ORDER NO. 10 DEEMING APPLICATION SUFFICIENT; ADDRESSING NOTICE AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On October 17, 2014, Trinity RTC GP, LLC (Trinity RTC or Applicant) filed with the Public Utility Commission of Texas (Commission) an application to obtain new water and sewer certificates of convenience and necessity in Harris County. On January 27, April 9, and July 24, 2015, Trinity RTC supplemented the application to cure deficiencies noted by Commission Staff.

II. Administrative Completeness

On August 28, 2015, Commission Staff recommended that Trinity RTC's application and notice, as amended, are sufficient for further review. Consistent with Commission Staff's recommendation, Trinity RTC's amended application and notice are deemed administratively complete.

III. Notice

Commission Staff recommended that Applicant be required to provide notice consistent with and in the manner specifically described in Commission Staff's August 28, 2015 pleading and the attached memorandum of Elisabeth English and Tracy Harbor of the Commission's Water Utility Regulation Division, including the approved forms of notice and affidavits of notice attached to the memorandum. Commission Staff recommended that Trinity SO be required to submit signed affidavits indicating that notice was provided, along with a copy of the actual notices issued, the map issued with the individual mailed notices, and tear sheets of the newspaper notice published, within 30 days of the date of notice and last publication date.

Consistent with Staff's recommendation, shall provide notice and proof of notice consistent with and in the manner specifically described in Commission Staff's August 28, 2015 filing and attached memorandum, including the approved forms of notice and affidavits of notice attached to the memorandum.

IV. **Procedural Schedule**

The following procedural schedule as proposed by Commission Staff is adopted:

Deadline for Applicant to file a copy of the actual notices issued, the map issued with the individual mailed notices, tear sheets of the newspaper notice published, and signed affidavits of notice.	October 5, 2015
Deadline for Comments, intervention or requests for a hearing.	30 days after last notice provided
Deadline for Commission Staff to file a supplemental procedural schedule	October 16, 2015
