COMMISSION STAFF'S PROPOSED REVISED PROCEDURAL SCHEDULE

I. Background

On October 17, 2014, Trinity RTC GP, LLC (Trinity RTC) filed with the Public Utility Commission of Texas (Commission) an application to obtain new water and sewer certificates of convenience and necessity in Harris County, Texas.

On March 25, 2016, Order No. 14 was issued requiring Trinity RTC to provide documentation addressing consents from overlapping water and sewer districts by April 25, 2016. On April 15, 2016, Trinity RTC filed a consent request. On May 16, 2016, Trinity RTC filed the actual consent. Order No. 14 also required Staff to propose a revised procedural schedule by May 27, 2016. Accordingly, this pleading is timely filed.

II. Proposed Supplemental Procedural Schedule

Staff has conferred with Trinity RTC and proposes the following revised procedural schedule:

Event	Deadline
Deadline for Commission Staff to provide revised maps and certificates to the parties for review and consent, or propose a revised procedural schedule	June 27, 2016
Deadline for Trinity RTC to file signed consent forms with the Commission showing consent to revised maps and certificates	July 1, 2016
Deadline for Commission Staff's recommendation on final disposition	July 8, 2016
Deadline for Staff and Trinity RTC to file a joint proposed notice of approval, including	July 22, 2016
