**CITY OF DALLAS REQUEST TO SET UP CONFERENCE BRIDGE FOR
APRIL 2, 2015 ORAL ARGUMENT ON INTERIM RATES**

TO THE HONORABLE WILLIAM NEWCHURCH ADMINISTRATIVE LAW JUDGE:

On March 27, 2015, the Administrative Law Judge issued SOAH Order No. 6 setting a hearing on April 2, 2015 at 9:00 Central Time, with the explanation that he would call the Counsel of Record listed on the Service List. As the parties' representatives and counsel are not in one place, and other representatives may desire to monitor the hearing, the City of Dallas requests that it be permitted to set up a conference bridge that the parties may call, and so that the ALJ and Counsel can all participate. Judge Newchurch will preside over the conference call at 9:00 a.m. on Thursday, April 2, 2015.




