Dear Judge Drews and Judge Bell:


Texas Industrial Energy Consumers (TIEC) and the Public Utility Commission Staff ("Staff") have conferred regarding Staff Exhibit 19, Robert Manning's Direct Testimony in Docket No. 35763, Exhibit 21, Brian Murphy's Direct Testimony in Docket No. 40443, and Exhibit 26, Matthew Troxle's Direct Testimony in Docket No. 32766, three exhibits that Staff offered for purposes of optional completeness.
