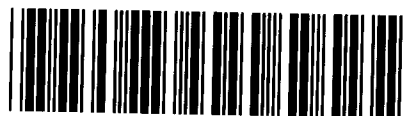

## METHOD USED TO ALLOCATE UTILITY CHARGES
