Lake Livingston Water Supply and Sewer Service Corporation, P.O. Box 1149, Livingston, TX 77351 has submitted an application with the Public Utility Commission of Texas to sell facilities and transfer water CCN No. 10147 in Tyler County, Texas to Tyler County Water Supply Corporation, P.O. Box 138, Spurger, TX 77660. The sale is scheduled to take place as approved by the Commission (V.T.C.A, Water Code § 13.301). The transaction and the transfer of the CCN including the following subdivision: Wayward Winds Estates. The area subject to this transaction is located approximately 7.5 miles North of downtown Spurger, Texas, and is generally bounded on the north by CR 4180; on the east by FM 92; on the south by CR 4195; and on the west by Antioch Road. The total area being requested includes approximately 120 acres and serves 16 current customers. This transaction will have the following effect on the current customer's rates and services: customers will be charged the prevailing rates of all Tyler County Water Supply Corporation and service will improve because maintenance personnel will be in closer proximity.

Affected persons may file written protests and/or request a public hearing within 30 days of this notice. To request a hearing you must:

- state your name, mailing address and daytime telephone number; (1)
- state the applicant's name, application number or another recognizable reference to this (2) (3)
- include the statement "I/we request a public hearing;"
- write a brief statement of how you, the persons you represent, or the public interest (4) would be adversely affected by the proposed transaction and transfer of the CCN; and
- state your proposed adjustment to the application or CCN which would satisfy your (5) concerns and cause you to withdraw your request for a hearing.

Only those persons who submit a written request to be notified of a hearing will receive notice if a hearing is scheduled. The Commission will issue the CCN requested in the referenced application unless a hearing is scheduled to consider the transaction. If no protests or requests for hearing are filed during the comment period, the Commission may issue the CCN 30 days after publication of this notice.


