**ORDER NO. 7
REQUIRING ADDITIONAL NOTICE AND MAPS**

On May 6, 2015, Lake Livingston Water Supply and Sewer Service Corporation (Lake Livingston WSC) filed additional mapping data in this proceeding. On May 8, 2015 Public Utility Commission of Texas (Commission) Staff filed a recommendation in accordance with the deadlines established in Order No. 6.

I. Additional Notice and Maps

Based upon review of the supplemental mapping information, Commission Staff has determined that additional parties must be provided notice of Lake Livingston WSC's application. Commission Staff recommended certain changes to the original notice and maps that Lake Livingston WSC had previously provided. Commission Staff further recommended that Lake Livingston WSC submit a corrected form notice and hard copy maps for approval by Commission Staff.

Consistent with Commission Staff's recommendation, on or before **May 22, 2015**, Lake Livingston WSC shall submit proposed notice and maps for review. The notice and maps shall follow the format specifically described in Commission Staff's May 8, 2015 filing and the attached memorandum of Debbie Reyes Tamayo and Tracy Harbour of the Commission's Water Utility Regulation Division.

II. Procedural Schedule

As noted by Commission Staff, pursuant to 16 Tex. Admin. Code § 24.109(a) the 120-day period for Commission review of sale and transfer application begins on the last date following (1) the application filing date; (2) the last date the applicant mailed required notice; or (3) the last date of publication of notice. The 120-day deadline will start on the date that Lake Livingston WSC provides notice to the additional parties identified in Staff's May 8, 2015 recommendation.

The following procedural schedule as proposed by Commission Staff is adopted:

Deadline for Lake Livingston WSC to file corrected proposed notice and hard copy maps	May 22, 2015
Deadline for Commission Staff to file a recommendation on corrected proposed notice and hard copy maps	June 5, 2015
