COMMISSION STAFF'S MOTION TO ADMIT EVIDENCE

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files this Motion to Admit Evidence. Staff request that certain evidence be admitted into the record in support of its Proposed Notice of Approval. In support of its Motion to Admit Evidence, Staff states the following:

I. Background

Lake Livingston Water Supply and Sewer Service Corporation (Lake Livingston WSC) filed an application requesting approval of the sale and transfer of its water facilities and corresponding water certificate of convenience and necessity (CCN No. 10147) for the Wayward Winds Estates subdivision in Tyler County, Texas. Lake Livingston WSC is the seller, and Tyler County Water Supply Corporation (Tyler County WSC) is the purchaser.

On May 13, 2016, Staff filed its Final Recommendation. Staff recommended that the Commission approve the application and the sale and transfer transaction between Lake Livingston WSC and Tyler County WSC.

On June 8, 2016, Staff filed its Proposed Notice of Approval.
