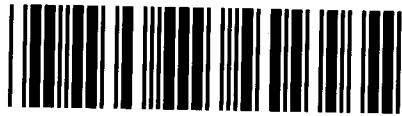

3. List of current customers. *with facilities*

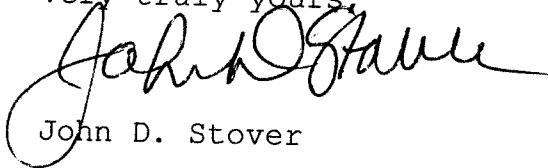
Please note that there are no cities with an extraterritorial
