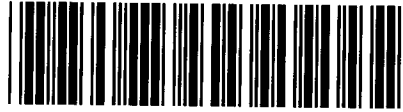



**ORDER NO. 48—CONCERNING PROPOSED FINDINGS OF FACT AND CONCLUSIONS OF LAW**

On April 12, 2005, the Administrative Law Judge issued an order stating that Fishtrap Properties, L.L.P. (Fishtrap) and the Executive Director could submit proposed findings of fact and conclusions of law in this case **on or before April 26, 2005**. These parties are able to submit proposed findings and conclusions after reviewing reply briefs filed by other parties. The Town of Prosper (Prosper) has already submitted proposed findings and conclusions, before it had an opportunity to review the other parties' reply briefs.

If, after reviewing the other parties' reply briefs, Prosper wishes to revise its proposed findings and conclusions and submit a revision **by April 26, 2005**, it may do so.
