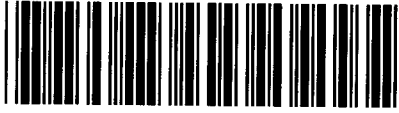


ORDER NO. 50-ABATING CASE

On June 21, 2005, the Town of Prosper (Prosper) and Fishtrap Properties, LLP (Fishtrap) submitted a joint motion for abatement stating that Prosper and Fishtrap have resumed serious settlement negotiations and hope to settle this matter in the near future; that the settlement should settle their differences in this docket; that they request a 45 day abatement to finalize the settlement; and that Prosper has contacted the Executive Director's counsel and has received his concurrence on the motion.

The motion is granted. This case is abated for 45 days from and after June 21, 2005, until 5:00 p.m. on August 5, 2005.

A proposal for decision will issue shortly after August 5, 2005, unless the parties file other requests, including a notice of settlement and motion for remand.
