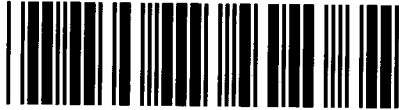



ORDER NO. 1
GRANTING MOTION TO CANCEL PRELIMINARY HEARING AND REMAND

On April 16, 2012, the Executive Director (ED) of the Texas Commission on Environmental Quality (TCEQ) filed a motion to cancel the preliminary hearing in this case, which is scheduled for April 23, 2012, and remand this case to the ED.
