ORDER NO. 4 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On February 9, 2015, Palo Duro Service Company, Inc. (Palo Duro) filed with the Public Utility Commission of Texas (Commission) an application to amend its certificate of convenience (CCN) No. 12200 in Parker and Wise Counties. On March 13, 2015, Order No. 3 was issued finding the application administratively incomplete and deficient, and establishing a deadline and opportunity to cure. On April 8, 2015, Palo Duro amended its application.

II. Commission Staff Recommendation on Administrative Completeness

On May 6, 2015, Commission Staff filed additional comments on the sufficiency of the application as amended. Commission Staff finds that Applicant's application as amended is sufficient for further review. Consistent with Commission Staff's recommendation, Applicant's petition is deemed administratively complete.

III. Commission Staff Recommendation on Notice

Commission Staff has reviewed Applicant's proposed notice with regard to applicable statutes and rules, and recommends Applicant send the notice as specifically described in Commission Staff's May 6, 2015 filing.

Consistent with Commission Staff's recommendation, Applicant shall provide notice as directed by Commission Staff. The notice shall be in the format of the sample notice attached to this Order.
