The area in this application is as follows:

The proposed Aledo Ridge Addition is 33.15 acres or simply 33 acres.

Palo Duro has requested an amendment to their CCN to add 258 acres. The 258 acres is a portion of a 328-acre tract developed some forty to fifty years ago. Palo Duro has served this area for in excess of 30 years. Palo Duro already holds a CCN for 70 acres adjacent to the 258 acres.


The application approved should be for 33 acres plus 258 acres or a total of 291 acres.



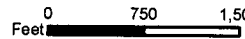
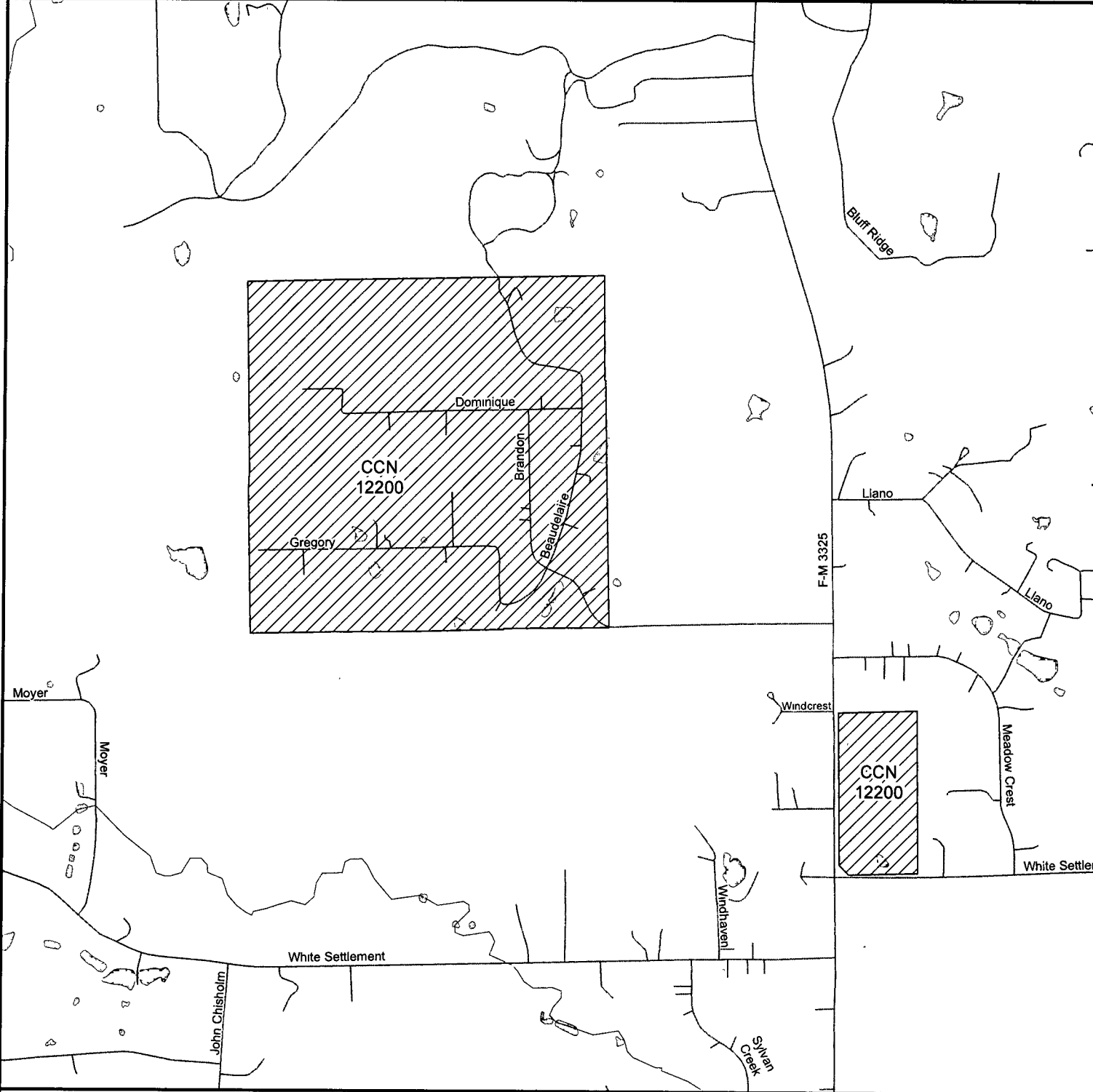
