#### **STATUS REPORT**

By Order dated September 7, 2012, the Administrative Law Judge ("ALJ") directed the parties to file a status report by October 5, 2012. Since that time, Applicant has submitted additional information to the Executive Director ("The ED") of the Texas Commission on Environmental Quality ("TCEQ"). The ED has reviewed this information, and determined that it need not seek a hearing on the merits.

#### **AGREED MOTION FOR REMAND**

The only parties are no parties in this matter are The Applicant, the ED, and the Office of Public Interest Counsel ("OPIC"). There are no issues which any of the parties believe require a

contested case hearing. The attorney for the ED and the attorney for OPIC has asked applicant to represent to the ALJ that they are each in agreement that this matter should be remanded to the Executive Director. Therefore, the Applicant, with the agreement of the ED and OPIC, respectfully requests that pursuant to 30 Tex. Admin. Code § 80.101, the ALJ remand this matter to the Executive Director.
