I received notice today that the Royse City and Verandah Communities CCN applications have been set for preliminary hearing together on Tuesday, December 2nd at the SOAH offices in Austin. However, in typical TCEQ/SOAH fashion, these dockets are set at the same time as the preliminary hearing in the highly controversial Southern Utilities Company docket 235 miles away in Tyler.
