ORDER NO. 6 DEEMING APPLICATION ADMINISTRATIVELY COMPLETE, ADDRESSING NOTICE; AND ESTABLISHING PROCEDURAL SCHEDULE

I. Application

On December 4, 2014, Concho Rural Water Corporation (CRWC) filed with the Public Utility Commission of Texas (Commission) an application to amend a certificate of convenience and necessity in Tom Green County. On June 1, 2015, CRWC amended its application.

II. Commission Staff Recommendation on Administrative Completeness

On June 29, 2015, Commission Staff filed additional comments on the sufficiency of the application. Commission Staff finds that the application is sufficient for further review. Consistent with Commission Staff's recommendation, the application is deemed administratively complete.

III. Commission Staff Recommendation on Notice

Commission Staff has reviewed CRWC's proposed notice with regard to applicable statutes and rules, and recommends that CRWC send the notice as specifically described in Commission Staff's June 29, 2015 filing and the attached memorandum of Elisabeth English and Tracy Harbour of the Commission's Water Utility Regulation Division.

Consistent with Commission Staff's recommendation, CRWC shall provide notice as directed by Commission Staff using the forms attached to Commission Staff's memorandum. CRWC shall file affidavits evidencing proof of notice by the deadline set forth below.

IV. Procedural Schedule

The following procedural schedule as proposed by Commission Staff is adopted:

Event	Date
Deadline for CRWC to provide the Commission with affidavit of provision of notice and copy of the actual notice sent; deadline to submit a publishers' affidavit of notice	Within 30 days of the date of notice and 30 days of the last publication date
Deadline for Interventions, filing of comments, or for Intervenors to request a hearing	30 days after the mailing or publication of notice, whichever occurs later
Deadline for Commission Staff to file an updated procedural schedule based upon the date notice was mailed	August 28, 2015
