







Concho Rural Water Corporation filed an application with the Public Utility Commission of Texas to amend a Certificate of Convenience and Necessity (CCN) for the provision of water utility service in Tom Green County.

The proposed utility service area is located approximately 6 miles west of downtown San Angelo, Texas, and is generally bounded on the north by FM 2288; on the east by FM 2288; on the south by FM 853; and on the west by Pulliam Ranch Road.

See enclosed map of the proposed service area.

The total area being requested includes approximately 28 acres and 5 current customers.

A request for a public hearing must be in writing. You must state (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, application number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application or CCN which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request or a written request to be notified if a hearing is set will receive notice if a hearing is scheduled.
