

On behalf of our client, Concho Rural Water Corporation ("CRWC"), we request approval of the proposed Certificate of Convenience and Necessity ("CCN") to cover the proposed Arden Road Public Water System (the "PWS"). In reference to the Commission Staff's First Request for Information, Docket No. 43895, we have answered the questions set forth:

> The project cost estimate is enclosed.

Concho Rural Water Corporation ("CRWC") hauls water to 4 customers on Arden Road; JP Falco, Thomas Petroleum, Arden Road Lodges ("ARL"), and the Dog House. Globe Energy is provided with potable water by another water hauler.

ARL does not provide any water to anyone other than its own living units. CRWC delivers all of

ARL potable water.

The water line construction has not begun.

➤ CRWC will be the water provider. CRWC will purchase up to 10 acre feet of water per year from the Upper Colorado River Authority through a current water purchase contract at \$350.00 per acre feet.
