The following is a description of the proposed CCN for the City of Corsicana, in Navarro County, beginning on the West side of Corsicana at Highway 31 and going in a counter clockwise direction around the South, East, North and back to the West side of Corsicana.

Beginning at a point on State Highway 31, on the West side of Corsicana, with the intersection of a creek called Cedar Creek,

Thence, in an Easterly direction, following the North line of the CCN for the Corbet Water Supply to the intersection of that line with the city limits line for the city of Retreat,

Thence, continuing in an Easterly direction with the city limits line for the City of Retreat to it's intersection with F. M. 709,

Thence, in a southerly direction with the city limits line for the City of Retreat to it's intersection with a boundary line for the CCN of Community Water Corp. on the East side of Retreat,

Thence, Northeast to Interstate Highway 45, Southeast and Southwest with the CCN line for Community Water Supply back to the city limits line for the City of Retreat,

Thence, south along the city limits line for Retreat to another intersection with a line for the CCN for Community Water Supply,

Thence, along the CCN line for Community Water Supply to the intersection with County Road SW 0010,

Thence, following SW 0010 to a point that intersects with the city limits line for the C1ty of Angus

Thence, turning ninety-degrees in a Northeasterly direction and continuing across country for a distance to a point that intersects with the city limits line for the City of Corsicana,

Thence, in an Easterly direction with the city limits line for Corsicana to a point that intersects with the East right of way for Interstate Highway 45.

Thence, South with the East line of Interstate Highway 45 to the intersection with County Road SE 1020,

Thence, in a Southerly direction with SE 1020 to the intersection with FM 739,

Thence, in a Northerly direction along a line for the CCN of MEN Water supply,

Thence, following a line for the CCN of MEN Water Supply through two turns in an Easterly direction across Highway 287 and across Lake Halbert, to it's intersection with County Road SE 0050,

Thence, in a North direction with SE 0050 to it's intersection with County Road SE 0040,

Thence, in an Easterly direction with SE 0040 to it's intersection with County Road SE 0070,

Thence, in a Northerly direction with SE 0070 to it's intersection with State Highway 31 on the East side of the City of Corsicana,

Thence, continuing across Highway 31 to a point that is 500 feet on the North side of Highway 31,

Thence, in a Westerly direction on a line 500' North of and parallel with Highway 31 to the intersection of said line with County Road NE 0010,

Thence, in a Northerly direction with NE 0010 to the intersection with County Road NE 0060,

Thence, West and North with NE 0060 to its intersection with County Road NE 0070,

Thence, in a Westerly direction with NE 0070 to a point that measures 500 feet East of Interstate Highway 45,

Thence, in a Northerly direction on a line parallel with Interstate Highway 45 and 500 feet East of the Interstate to a point that intersects with Briar Creek,

Thence, in a Westerly direction with Briar Creek across Interstate Highway 45 and to he West side of Business 45,

Thence, with a line for the existing CCN of the City of Corsicana, to it's intersection with FM 3383,

Thence, in a Northwest direction with FM 3383 to it's intersection with County Club Lane,

Thence, in a Southwest direction with Country Club Lane and projecting across country on a line with Country Club Lane to the intersection with County Road NW 1060,

Thence, in a Southeasterly direction with NW 1060 to a point in the city limits line for the City of Corsicana,

Thence, in a Southeasterly direction with the South city limits line at said point to it's intersection with the existing CCN for the City of Corsicana,

Thence, in a Southerly direction with the existing CCN line for Corsicana to a point for a line 500 feet on the North side of and parallel with Dobbins Rd.,

Thence, in a Southwest direction on a line 500 feet North of and parallel with Dobbins Rd. to it's intersection with County Road NW 1020,

Thence, in a North and then in a West direction with NW 1020 to it's intersection with County Road NW 1040,

Thence, in a Southerly direction with NW 1040 to it's intersection with the existing city limits line for the City of Corsicana,

Thence, along the existing city limits line for Corsicana in a West and South direction going across FM 744, to the intersection with County Road NW 2004, also known as the Drane Slab,

Thence, in a Westerly direction with NW 2004 to it's intersection with FM 744 and continuing West with FM 744 to a point 500 feet West of County Road NW 2090,

Thence, in a Southerly direction 500 feet West of and parallel to NW 2090 to a point 500 feet North of State Highway 31,

Thence, in a Westerly direction on a line 500 feet North of and parallel with Highway 31 to an intersection with a creek known as Cedar Creek,

Thence, in a Southerly direction with Cedar Creek to the Place of Beginning at Highway 31 on the West side of the City of Corsicana.

Excluded from this description of the CCN for the City of Corsicana is the CCN of Community Water Supply at Beaton Lake Estates.
