



AMENDMENT TO

AGREEMENT DESIGNATING AREAS AND CUSTOMERS TO RECEIVE RETAIL WATER UTILITY SERVICE BY AND BETWEEN ANGUS WATER SUPPLY CORPORATION AND CITY OF CORSICANA, TEXAS, EFFECTIVE JULY 12, 2005

The AGREEMENT DESIGNATING AREAS AND CUSTOMERS TO RECEIVE RETAIL WATER UTILITY SERVICE (Agreement) by and between Angus Water Supply Corporation (Water Supply Corporation) and City of Corsicana, Texas (City) (hereinafter, Water Supply Corporation and City, collectively referred to as Parties) and effective July 12, 2005, is amended as follows:

WHEREAS the Texas Commission on Environmental Quality (TCEQ) staff recently notified Parties that the portions of the Agreement that involve the transfer of facilities from Water Supply Corporation to City described in Paragraph (3) of the Agreement will not be processed as an agreement under Section 13.248 WATER CODE as referenced in the Agreement but will instead require an application for sale, transfer, or merger of a retail public utility (STM) application; and

WHEREAS Parties intend that an STM application be filed so that TCEQ can complete all actions needed to effectuate Parties' full intent in entering into the Agreement as soon as possible;

NOW THEREFORE, in consideration of the mutual promises and agreements contained in the Agreement, as amended by this document (Amendment), the Parties agree as follows:

(1) The Agreement remains in full force and effect except as expressly stated in this Amendment. The Parties' mutual promises and agreements contained in the Agreement apply to the Agreement as amended unless expressly provided in this Amendment.

(2) The facilities described in Paragraph (3) of the Agreement will be transferred from Water Supply Corporation to the City on the date that the Parties' closing documents for the STM application for those facilities are submitted to the TCEQ.

(3) The second sentence of Paragraph (5) of the Agreement is amended to read as follows:

(5) The credits will begin on the first bill that City issues to Water Supply Corporation after the closing documents described in Paragraph (2) of the Amendment are submitted to the TCEQ.

(4) The first sentence of Paragraph (6) of the Agreement is amended to read as follows:

(6) City agrees to begin providing service to the area described in paragraph (3) of the Agreement and as depicted in Exhibit 1 to the Agreement within 60 days after the closing documents described in Paragraph (2) of the Amendment are submitted to the TCEQ.

(5) Paragraph (7) of the Agreement is amended to read as follows

(5) The Amendment shall be submitted to the TCEQ following execution of the Amendment by the Parties. The Agreement as amended by the Amendment shall be considered binding and effective as of the date on which the closing documents described in Paragraph (2) of the Amendment are submitted to the TCEQ.

IN WITNESS WHEREOF, the Parties have executed this Amendment to the Agreement effective the date of the last signature.
