

On the same day the motion is transmitted to the chief clerk, please provide copies to Robert Martinez, Director of the Environmental Law Division (MC 173), and Blas Coy, Public Interest Counsel (MC 103), both at the same TCEQ address listed above. If a motion is not acted on by the commission within 45 days after the date of this letter, then the motion shall be deemed overruled.






