### ORDER NO. 3 SCHEDULING PREHEARING CONFERENCE

On December 8, 2009, Double Diamond Utilities Company (Applicant) filed a motion for continuance. On December 9, 2009, White Bluff Subdivision Ratepayers (Protestant) filed their response in opposition to Applicant's motion. Protestant's response (1) makes reference to the final order recently issued in SOAH Docket No. 582-08-0698; TCFQ Docket No. 2007-1708-UCR, contending that the current docket uses the same consolidated accounting for revenue requirements that the Commission has now rejected, and (2) requests an escrow for potentially refundable utility payments, if the motion for continuance is granted. Having considered these matters the Administrative Law Judge concludes that it would be beneficial to schedule a prehearing conference to fully consider these matters.

NOW, THEREFORE, IT IS ORDERED that a prehearing conference will be convened on January 5, 2010, at 10:00 a.m. at the State Office of Administrative Hearings, William P. Clements Building, 300 West 15<sup>th</sup> Street, Fourth Floor, Austin, Texas.

The Parties are requested to be prepared to address (1) the effect of the final order in TCEQ Docket No. 2007-1708-UCR, specifically, should this proceeding be dismissed or abated to allow the Applicant to file an application consistent with the recent TCEQ final order; (2) should the potentially refundable portion of utility payments be put in escrow on a going-forward basis; (3) Applicants motion for continuance; (4) the procedural schedule for this proceeding if it is continued and not dismissed or abated, and (5) any pending motions. The Parties are invited, but not required, to provide a written statement of position on these matters prior to the prehearing conference.
